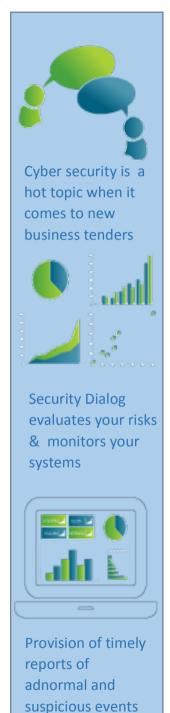

# The Security Dialog Approach

We have a new and unique service based approach that lets you first understand the threats that you may be exposed to, and then gain on-going protection from the risks. It's a scalable "pay-on-demand" service so you only pay for what you use. There are three simple steps.

# Step One - A Security Dialog

This step involves a short workshop where you tell us about your business and the systems you use to support and protect it. We create a diagram of your systems and your business. Together we identify possible cyber threats, the likelihood of them being realised, the impact they would have and any relevant compliance issues. This is used as the framework for Step Two.

### Step Two - Initial Risk Assessment

We then connect some or all of your IT and communications systems to our monitoring service so we can start to see what is happening on your systems and whether there are any concerns from a risk and compliance perspective. This is completely secure; there should be no impact on the performance of your systems.

We will monitor these events over a period, usually 1 month, analyse what is happening and keep you informed with reports on a regular and timely basis, including recommendations for remedial action in the event of issues being found. If there is nothing unusual to report we will still let you know for peace of mind.

### Step Three - Ongoing Risk and Compliance Monitoring

Based on the results of step two, we provide you with the ongoing managed services that you need, no more, no less. As time passes and your business evolves, these services can be re-tuned, with the monthly costs being adjusted accordingly.

Options are easy to understand and include things such as the hours of service availability, the period that you want your data kept, the frequency of reporting etc. As simple as choosing your domestic TV and broadband options.
